## VILLAGE OF DANE BOARD OF TRUSTEES MINUTES Monday, August 5, 2024

1. Call to Order

President Don Postler called the meeting to order at 6:30 pm in the small meeting room of the Dane Village Hall. A quorum of the board was present.

2. Ågenda Confirmation

The agenda was confirmed as presented.

3. Announcements by Village President or Board Members

Trustee McKiernan shared an article from the Municipality Magazine about Hillsboro and their Habitat for Humanity efforts to provide affordable housing. President Postler reminded those in attendance that Vollrath would be holding an Open House on Saturday August 24 from 11 am -3 pm. The Dane County Board will be holding the August 15<sup>th</sup> meeting at the Schumacher Farm. The event starts at 6:30 pm and the Board meeting will begin at 7 pm.

4. Public Input

Jean Steele was registered to give Public Input. Jean provided photos of the property at 128 W Main Street; the photos showed that the property owner is not in compliance with village ordinances. She is concerned that the remodel permit was issued and the nothing more will get cleaned up in the yard. The property continues to be an eye sore. She contracted Poison Ivy along the fence line between the two properties and that is a huge concern for her.

Dane County Sheriff Report by Brad Duffrin Deputy Duffrin's report was given in verbal and written format regarding the speed board sign placement, St Michaels drills on Active Shooters with staff members, Kick It with a Cop was well attended with 30-50 participants, NECC Court has been changed to every other month which was recommended by the Court Attorney.
- WWDDV EMS Report by Roger Schmidt Trustee Schmidt gave the WWDDV EMS Report in written and verbal form. Ambulances were back in service, the cot scales are in place, the Village of Dane had 2 calls in June 2024. The study with Middleton is getting started.
- DCCVA Report by Roger Schmidt
   The Report was filed in verbal and written form. The DCCVA meeting was on July 10, 2024 and Executive
   Council was July 15, 2024. The Village of Dane is hosting a DCCVA in-person meeting on Wednesday,
   September 18, 2024 from 5 pm–7 pm in the large community room at Village Hall. This meeting is open to the
   public.
- Dane -Vienna Fire District Report by Julie McKiernan The report was submitted in written and verbal form. The District Board asked if Johnson and Block had provided a quote for an Audit.
- 10. Public Works Report by Shane Clapper

Shane Clapper is working on the Lead and Copper Report for the DNR, storm water drains are being cleared to prevent overflow, the baseball schedule is wrapping up for this season, Highway V road work started on August 5, 2024 and should be wrapped up by later fall. Dane County Sheriff's Department hung speed monitors to record traffic activity in the village on August 5, 2024.

- b. Appointment of Jean Steele to the Parks, Recreation, and Forestry Committee Motion (Schmidt/Morgan) to recommend Jean Steele be appointed to the Parks, Recreation, and Forestry Committee effective on August 5, 2024. Motion carried.
- c. ATV/UTV Use of Village Streets Discussion held on the use of ATV's and UTV's on streets in the Village of Dane. The Roxbury ATV Club was represented at the meeting. The club has about 57 members. The Board of Trustees are referring this issue to the Plan Commission for further research and discussion.
- d. Review Park Improvement Financials & Bids

Discussion was held on updates to Capitol Valley Park from the Comprehensive Outdoor Recreation Plan. A tennis and basketball court, a pickle ball court with fencing around each, and a walking path through the park is being planned for installation. Shane is working on getting the bids for the asphalt, fencing, landscaping, and possible lighting.

Motion (Browne/Morgan) to approve the multi-sports courts, walking paths, and upgrades to Capitol Valley Park. Motion carried.

- e. Dane County Trees & Arborist Labor Discussion was held on free trees being offered by Dane County Parks Director to the village. Further discussion on how many trees the village would be interested in planting and where would be desired places to plant new trees.
- f.
